### **SUBJECT**:

Protest against Mathew Scholtz SSP#11 filed by Rahal Ducati Moto from an incident on lap 14 of Supersport Race 2 where a pass was made by Mathew Scholtz SSP #11 on PJ Jacobsen SSP #15, which resulted in PJ Jacobsen SSP#15 crashing and not finishing the race. The protest alleges that action should have been taken against Mathew Stoltz SSP#11 for unsafe riding leading to the crash of PJ Jacobsen SSP #15.

#### **FACTS / STATEMENTS DURING THE HEARING:**

### Video Review

The Stewards reviewed all available video on the replay system including the incident (two angles) and post race TV interviews.

#### Summary of Interview of Mathew Scholtz with Ed Sullivan

I passed inside of turn 11, and felt the pass was clean. There was enough room and I took the pass. I held my line on the exit. I thought the pass the clean and then felt PJ make contact into the side of back tire. I was faster and I felt that I could make a clean pass in that corner.

#### Summary of Interview of PJ Jacobsen with Richard Alexander and Ben Spies

I was defending with a tight line, and Scholtz came inside and then rode wide and stood his bike up a bit and I had no where to go. I don't feel Scholtz crashed me on purpose, but I feel that there was no chance the pass would be successful. He was faster overall and could have passed without causing me to crash or passed in another corner.





# Decision of the FIM North America Stewards Protest Panel

#### **DECISION OF THE FIMNA STEWARDS PANEL:**

The FIMNA Stewards ruled initially during the race that it was a race incident and declined to take any action. After the protest was filed and after interviewing all parties involved, reviewing all available video, and examining Section 1.21 Behavior during Practice and Race of the 2024 MotoAmerica Regulations, the decision is made to impose a 3 second penalty against Mathew Stoltz SSP#11 assessed after the race for his role in the incident. We feel both riders share some responsibility for the incident.
